"Renato Nazzini is a Professor of Law and Director of Research of the Centre of Construction Law and Dispute Resolution at King's College London and a partner at LMS Legal LLP (London) where he focuses on arbitration, litigation and ADR as well as antitrust, regulated sectors, state aid, and European Union law. Professor Nazzini is an expert in commercial arbitration, ADR and civil procedure and in competition law. Previously, he was Professor of Competition Law and Arbitration (formerly Reader in Law) at the University of Southampton, which he joined from the Office of Fair Trading, the UK competition authority, where he was Deputy Director of the Legal and Policy Department and led or advised on major areas of enforcement and policy, including construction, financial services, private enforcement, and the review of the policy on abuse of dominance under Article 102 TFEU. While at the Office of Fair Trading, Professor Nazzini worked with a number of European and international institutions including the European Commission and the Organization for Economic Cooperation and Development (OECD) and was appointed to the ICC Task Force on Arbitrating competition law issues. He is General Co-editor of Global Competition Litigation Review and is a member of the editorial board of the European Business Law Review. Professor Nazzini holds doctorates from the Universities of Milan and London and has been Visiting Professor at the University of Turin and Honorary Fellow at the British Institute of International and Comparative Law. He is a Solicitor of the Senior Courts of England and Wales, an Italian advocate, and a Member of the Chartered Institute of Arbitrators. He has acted as arbitrator and has advised and represented clients in competition matters and in complex commercial disputes in arbitration, both ad hoc and institutional, and court proceedings. He has written or edited a number of books, including, as editor, Transnational Construction Arbitration: Key Issues in the Resolution of Construction Disputes (Informa, 2018) and, as author, Competition Enforcement and Procedure (OUP, 2016) and The Foundations of European Union Competition Law: The Scope and Principles of Article 102 (OUP, 2011)."
